**Rule Changes:**

In a letter addressed to the ACDA Committee, C. Lennon moved that the following rules be amended to read as follows:

Rule 11.13. "Any player who transfers to another team during the season will not be permitted to transfer again during that season, unless approved by the Committee".

Rule 11.14. "All transfers and registrations will cease six weeks before the end of the current season".  
Second: J. Dunn                      Passed

Rule 11.16. "The player who is about to take their turn must not commence their throw until the previous player has returned behind the oche".

Constitutional Change:

In a letter addressed to the ACDA Committee, J. Dunn moved that there be a change to the Constitution to include a clause that states: "In order to stand as an Executive member, a general Committee member must have been on the Committee for a minimum period of twelve (12) months". This will have provided the member with enough experience to have an understanding of the requirements of the Executive positions that have been vacated at an Annual General Meeting.
