LIFE MEMBERSHIP

LIFE MEMBERSHIP REQUIREMENTS

A life membership is the highest award available to recognize the exceptional contribution of individuals to the Adelaide Central Darts Association. It is therefore only to be awarded in exceptional circumstances.

General Considerations.

In considering the award of life membership an individual should have demonstrated significant, sustained & outstanding service enhancing the reputation of the Adelaide Central Darts Association.

The general attitude of the nominee should reflect a dedication to the values of the association.

Commitment to the principles of good sportsmanship.

- . SUPPORTING ASSOC. IN TOURNAMENTS AND VOLUNTARY WORK.
- . COMMITTEE YEARS OF SERVICE TO BE MORE ATTAINABLE IN THIS CULTURE
 - 10+ AND 5 YEARS ON COMMITTEE OR
- SERVICE TO THE COMMITTEE AND ASSOCIATION ACUMILATING TO 15 YEARS
- IE. 8 YEARS PLAYING ,JOIN COMMITTEE AND SUPPORT ASSOCIATION FOR 7 YEARS
- 15 YEARS IS THE AMOUNT NEEDED.

These points apply in whatever role the nominee has participated in during their service to the Adelaide Central Darts Association.

 The committee may consider the recommendation of any person to be elected a life member of the Adelaide Central Darts Association. Such recommendation shall be submitted in writing to the committee not less than 4 weeks prior to the AGM.

- 2. On receiving of a recommendation the committee shall prepare a report outlining the history of the nominee for life membership. Together with its recommendation as to the suitability or otherwise of the award.
- 3. The committee report shall be presented to the AGM & then the person may be elected by a three quarter majority of those present and entitled to vote.
- 4. Life members will be presented with a suitably framed certificate under the logo of the association & bearing the signature of the president of the association (or a nominee) at the time of election. The person shall also receive a numbered Adelaide Central Darts Association Life Membership badge. The persons name shall also be listed in the constitution, web site & other official documents.
- 5. Life members have the same privileges as other members of the association. Life members shall be exempt from membership & seasonal competition fees. Life members are to receive a written invitation to attend the association's presentation dinner & be offered a ticket at a subsidized price of 50% of the full ticket cost.

RETRACTION OF LIFE MEMBERSHIP

Retraction of a Life Membership award may occur where the recipient has conducted him/herself in a manner that reflects directly & adversely on the image or activities of the Adelaide Central Darts Association.

This provision will only be exercised in exceptional circumstances and will require the full support of the Adelaide Central Darts Association Executive committee.

As part of the deliberations, the Life Member in question is also to be given an opportunity to present their case for retention of their Life Membership status.

HONONARY LIFE MEMBERSHIP.

. 10+YEARS PLAYING IN THE ASSOCIATION.

Honorary Life Members will be presented with a suitably framed certificate under the logo of the association & bearing the signature of the president of the association (or a nominee) at the time of election.

The member has no voting privileges.

Members will be given a written invitation to attend the associations presentation dinner but will not be subsidized by the Association.

HONORARY MEMBERSHIP

HONORANRY MEMBERSHIP

On recommendation of the Adelaide Central Darts Association Executive Committee Honorary Membership may be granted to an individual, who has played or is playing a significant role to the benefit of the Adelaide Central Darts Association. Or to someone who has made a significant contribution to the welfare of the association.

The individual will have shown a strong support for the association.

The membership has no voting privileges.

Members will be given a written invitation to attend the associations presentation dinner but will not be subsidized be the Association.

Honorary Members will be presented with a suitably framed certificate under the logo of the association & bearing the signature of the president of the association (or a nominee) at the time of election. The persons name shall also be listed in the constitution, web site & other official documents.
